2. If the total job time exceeds hours specified, a 100.00 charge is applied and must be paid in cash at beginning of specified hour.
3. In the event of a postponement or cancellation of this contract, all deposits will be forfeited (deposits equal at least 50% of contract).
"All deposits reserved for engagement are nonrefundable"
4. If Audio Works becomes unable to provide services due to complications beyond Audio Works control, a reputable replacement shall be provided at no more than the original price agreed on.
5. However, in the event Audio Works fails to comply with the terms of this contract or find a suitable replacement due to any event or act outside of the control of Audio Works. Audio Works liability is limited to the refund of the deposits or payment received.
6. 50% of your total contract is your deposit, remaining balance due at event in cash before the start of event time specified.
7. A \$40.00 charge will be added for any returned down payment checks received. Any delay in payment will result in a \$50.00 or 30% per week late fee, whichever is greater unless prior written arrangements are made.
